- iii) What We Learned at the CCSA Conference
 A bill was signed into law that will require more transparency in charter school operations. This law would require charter organizations with more than one school to set up a teleconference with two-way communication at each school to allow people to participate in a school board meeting. Several new bills have been introduced by Sacramento politicians that could close hundreds of charter schools throughout the state. See the attached guide entitled "Stand for All Students, Defend Great Schools Mobilization Guide" for details.

 It was suggested during this discussion that there should be on site board training on the Brown Act.

 Darin Soukop will take the lead on this. There was a discussion on how often evaluations for the executive director should take place. It was suggested that every 2-3 years might be a good time frame unless the executive director is a new hire and then a different schedule might be better, for example, 6 months for a first evaluation and then another at 1 year.
